Economy: IMF predicts growth to reach 4.0 percent by 2020

Following its annual bilateral discussions with Mauritius, the IMF Executive Board submitted a summary of its views on the country's economic performance to the Mauritian authorities.



It is estimated that growth in the economy will increase to 3.8 percent in 2016, and reach 4.0 percent in 2020. It is expected that inflation will gradually pick up from a historic low of 1.3 percent to reach 2.6 percent in 2020. The IMF forecasts a constant rise in both public and private investment rates, with Gross Domestic Investment reaching 28.4 percent of GDP by 2020.

In their statement, the Executive Directors of the IMF commended the country's efforts to maintain a stable macroeconomic environment and foster a more diversified economy. They nonetheless noted the macro-financial risks from a potential slowdown in offshore activities and vulnerabilities in the banking sector. They encouraged the authorities to continue to strengthen macroeconomic and financial sector resilience and to pursue structural reforms to raise productivity and growth.

The IMF further welcomed the authorities' commitment to raise growth and competitiveness by addressing infrastructure bottlenecks and skills mismatch, reducing the cost of doing business, and facilitating further diversification of the economy.

Africa is open for business: The African Development Bank calls on African private sector

Africa's private sector will continue to lead the continent towards economic transformation, African Development Bank President Akinwumi Adesina said Monday at the launch of the fourth Africa CEO Forum in Abidjan, on 21st March 2016.

Addressing some 500 CEOs from 43 African countries and 20 more worldwide, he said, "The 'Africa rising' story remains strong. Yes, African economies face economic headwinds from the significant decline in the price of commodities ... but African economies remain resilient. While the global economy is projected ... to grow at 3% this year, Africa is projected to grow at 4.4% in 2016, and to accelerate ... to 5% in 2017".

He set out a clear vision of the work that governments must do to allow the private sector to

reach its maximum potential: ensuring macroeconomic stabilization and fiscal consolidation, broadening the tax base, and deepening domestic capital markets. In addition, he said, governments need to continue to address infrastructure deficits, break down barriers to regional integration, and fast-track key reforms.
