## Presentation on the Trade Finance Facility of BADEA, Wednesday 7 December 2016, 10hrs, MCCI, Port Louis

A delegation from the Arab Bank for Economic Development in Africa (BADEA) will be on a visit to Mauritius from 3 to 9 December 2016. In this context, a presentation on the theme "Trade Finance Facility of BADEA" will be held on **Wednesday 7 December 2016** at 10hrs at the seat of the MCCI, 2nd Floor Anglo-Mauritius House, Port Louis.

Arab Bank for Economic Development in Africa (BADEA) is a financial institution which operates for the strengthening of economic, financial and technical cooperation between Arab and African countries.

BADEA has set up new facilities for private sector enterprises and financial institutions including a Trade Finance Facility to fund imports from Arab countries to Mauritius. Dr. Hesabelrasoul Abbas Elbashir, Chief, Trade Finance and Private Sector Division and Mr. Wadi Abdurahim Yousuf, Principal Engineering Expert, from BADEA will apprise members of the Mauritian business community on the different opportunities that can be exploited through the Trade Finance Facility.

### Increase of 9.5 percent in tourist arrivals over first nine months of 2016

According to Statistics Mauritius, tourist arrivals increased by 9.5 percent in the first nine months of 2016 as compared to the same period in 2015 to reach 880,890.

In this period of 2016, France, our top tourist generating country, registered a growth of 6.2 percent. Tourist arrivals from Turkey increased by nearly 400 percent 546 as a result of new direct flights. A decline of 11.8 percent and 23.3 percent is however noted for China

and Russia respectively due to a decrease in seat capacity.

It is estimated that tourist arrivals for the year 2016 would reach 1,320,000, representing an increase of 9.9 percent over the 2015 figures. The Bank of Mauritius has revised upwards its tourism earnings forecasts for the year 2016 to Rs 56.6 billion, representing an increase of 12.7 percent.

### MARC: Promoting Harmonious Employment Relations Through Mediation

The MARC Permanent Secretariat was invited to deliver a presentation on the MARC Arbitration and Mediation Framework on the occasion of a workshop organised by the Commission for Conciliation and Mediation (CCM) on 17 November 2016, at Quatre-Bornes. The presentation was delivered by Mrs. Anjana Chikhuri, Analyst of the MCCI Legal and Business Facilitation Division.

The presentation highlighted the scope for resolution of employment-related disputes through the MARC ADR services, namely under Section 63 and Section 64 of the Employment Relations Act 2008, which provides for 'voluntary arbitration' and 'meaningful negotiations' respectively.

On the occasion, the MARC Permanent Secretariat also announced a forthcoming special mediation package for employment-related disputes, based on the MARC Mediation Rules and on a panel of specialised mediators.

Following the workshop on 'Potential Exporters Programme' organised by Small and Medium Enterprises Development Authority (SMEDA) on 27 September 2016, follow-ups sessions were organised for the different sectors namely jewellery, food, printing, furniture, textile, metal and handicraft during the month of November.



During the follow-up sessions for each sector, entrepreneurs were explained how to adopt GS1 Standards specific to their sector of activity for national trade as well as for exportation. They also had the possibility of understanding the endless opportunities and the various benefits of adopting GS1 Barcodes for their businesses.

John Danilovich, Secretary General of the International Chamber of Commerce, said ICC was committed to responsible business conduct. He said the business vision for progress comprised three key concepts: innovation, collaboration and regulation.

### Tapping into digital innovation to promote trade and investment in Africa

Leaders at the Trade Promotion Organization (TPO) Network World Conference and Awards 2016 in Marrakech, Morocco, on 24-25 November underline the need to manage the rise of digitalization to connect more businesses to markets and to foster inclusive trade.

This biennial conference – hosted this year by Maroc Export under the high patronage of His Majesty King Mohammed VI of Morocco in partnership with the International Trade Centre (ITC) – is an opportunity for organizations to forge new partnerships with other similar organizations in their regions and beyond.

ITC signed a memorandum of understanding with the Iranian Ministry of Industry, Mine and Trade, as well as a letter of intent with the Turkish Exporters Assembly to work with their national trade and investment promotion organizations to help small and medium-sized enterprises (SMEs) reach new markets.

ITC agreed to establish an online knowledge-sharing platform to help trade and investment promotion organizations network and share experiences. Additional work will be undertaken to research the economic and social impact of trade and investment promotion.
