A good morning to all of you

The journey travelled by the forerunners of the industry has been remarkable. Many industries have even crossed the frontiers of the local market and have solidly implanted their business ventures in the region and even beyond. Today we are proud that the industry is highly diversified. Another remarkable feature of the industry is that it has placed the 'Made in Moris' label as products of choice for our consumers. Many of the enterprises have proved that they can be innovative with differentiated products.

#### Ladies and Gentlemen,

This Government believes that the industry sector can thrive only through a conducive business environment. We must endeavour through all means to reduce and even eliminate administrative hassles on the way of our enterprises. We must improve our ranking in the World bank ease of doing business index. In this context, a public and private sector committee has been set up by this Government is exploring all avenues for business facilitation.

### Ladies and gentlemen

Business facilitation means also the digitalisation of our procedures. In this context, my ministry is taking measures to facilitate commercial procedures with less time consuming and more eco-friendly. An E- Platform will be set up for businesses applying for permits and licences. The National Single Window was launched in January 2016 for processing of export and import

permits. Last year, I focused on the import permit procedures which had been computerized and am happy to announce that all our export procedures will be finalized by end of April. It's a major step for e-trading.

The Price fixing Unit at my ministry is embarking on a fully computerized system. Importers of controlled-price items for example such as milk and pharmaceutical products will be able to submit data and documents online to the department and price fixing will be communicated online. This Platform will undoubtedly help to reduce business processing time will be more eco-friendly. In the same vein, in the bunkering sector, operators can apply and receive approval for their importation after only 2 hours after their application.

E-commerce platforms are evolving very rapidly. More and more traders are focusing on online sales. And more consumers, particularly the youth are being influenced by online purchase. We can buy nearly everything in front of our PC. I can understand your concern about it. But we have to adapt to changes in the methods of purchasing.

Recently, during a half-day workshop organised by my ministry, some recommendations have been made to review and update our legislations. It is a very complex matter. In fact, we will have to protect local consumers against some international traders which are not registered in our country, with no physical address and representatives in Mauritius.
